Who We Are...What We Do...

As students, faculty and staff work toward closing out another semester, the Dean of Students Office continues to serve as a resource for the campus community regarding a variety of different needs.

Academic Integrity.

As an academic community, Rutgers is committed to fostering an intellectual and ethical environment based on the principles of academic integrity. An online tutorial has been developed by our office to support this commitment and to promote a strong culture of ethics and integrity at Rutgers. At this time, all new students should have completed this tutorial on Sakai. Students are also required to affirm that they understand the policy and agree to abide by it in all their academic work.

Code of Conduct.

The Rutgers University Code of Student Conduct outlines the disciplinary process for students across all three campuses. The Camden Campus' Office of Student Conduct is overseen by the Division of Student Affairs. The code identifies prohibited moral and ethical behaviors including, but not limited to: theft, violence, disorderly conduct, bigotry, and harassment. The campus' Office of Student Conduct is responsible for issuing sanctions for all these non-academic integrity offenses and oversees the process in which disciplinary action is implemented. It is up to the students to familiarize themselves with these policies.

Raptor CARES.

Our office works closely with faculty, staff, students, and families to provide care and support for students of concern who may be in distress. Assistance can be provided for issues related to personal, family, financial, medical, or academic concerns.

SafeZone (LGBTQAI Student Support and Ally Program).

SafeZone is a campus-wide initiative to promote a safe and inclusive campus climate, and educate students, faculty and staff on issues facing the LGBTQAI community.

2017-2018 FAFSA

NOW AVAILABLE ONLINE AT WWW.FAFSA.ED.GOV

Starting with the 2017–18 **Free Application for Federal Student Aid (FAFSA)**, the following changes have been put in place:

Students are now able to submit a FAFSA earlier. Students have been able to file a 2017–18 FAFSA since Oct. 1, 2016, rather than beginning on Jan. 1, 2017. The earlier submission date is a permanent change, enabling students to complete and submit a FAFSA as early as Oct. 1 every year. (There is NO CHANGE to the 2016–17 schedule. The FAFSA became available Jan. 1 as in previous years.)

Students now report earlier income information. Beginning with the 2017–18 FAFSA, students are required to report income information from an earlier tax year. For example, on the 2017–18 FAFSA, students (and parents, as appropriate) must report their 2015 income information, rather than their 2016 income information.
